## ORDER OF RESTITUTION

MICHAEL PRATT (1),

Defendant.

Pursuant to joint motion, IT IS HEREBY ORDERED:

1. Pursuant to 18 U.S.C. § 1593, Defendant Michael Pratt (hereinafter “Defendant”) shall pay restitution in the total amount of \$ 75,568,283.47, as a result of Defendant’s conviction for conspiracy to commit sex trafficking by force, fraud, and/or coercion, in violation of 18 U.S.C. § 1594(c) and committing sex trafficking by force, fraud and/or coercion in violation of 18 U.S.C. § 1591.

2. Defendant shall pay \$16,922,798.00 in restitution to the victims identified in Attachment A, on a *pro rata* basis, for the gross income generated from the scheme. Attachment A shall be sealed.

3. Defendant shall pay \$58,645,485.47 in restitution to the victims and providers of compensation identified below for the specified amounts. The victims shall be paid on a *pro rata* basis. Pursuant to 3664(j)(1), any provider of compensation who has paid a victim for a loss shall receive the restitution owed to that victim. However, all victims shall be paid their full restitution before a provider of compensation. Therefore, all victims identified below shall receive restitution in full before the providers of compensation receive

1 restitution on a *pro rata* basis. The names of the specific victims are identified in  
2 Attachment B, which shall be filed under seal.

3 4. Restitution shall be joint and several with all co-defendants and co-conspirators  
4 ordered to pay restitution for the same losses. The presently known co-defendants and co-  
5 conspirators of Michael Pratt are Matthew Wolfe, Ruben Andre Garcia, Theodore Wilfred  
6 Gyi, and Valerie Moser.

7 5. After considering the factors set forth in 18 U.S.C. § 3664(f)(2), the Court finds that  
8 the Defendant has the ability to pay the restitution as set forth in the following payment  
9 schedule:

10 a. During any period of incarceration, Defendant shall pay restitution through the  
11 Inmate Financial Responsibility Program at the rate of 50% of Defendant's income, or \$25  
12 per quarter, whichever is greater.

13 b. Upon release from custody, Defendant shall pay restitution at the rate of at least  
14 \$200 per month, subject to modification upon further agreement of the parties or order of  
15 the Court.

16 6. This payment schedule does not foreclose the United States from exercising all legal  
17 actions, remedies, and process available to collect the restitution judgment, including but  
18 not limited to remedies pursuant to 18 U.S.C. §§ 3613 and 3664(m)(1)(A).

19 7. Defendant shall forward all restitution payments, by bank or cashier's check or  
20 money order payable to the "Clerk, U.S. District Court" to:

26 8. The Court has determined that Defendant does not have the ability to pay interest.  
27 The interest requirement is waived pursuant to 18 U.S.C. 3612(f)(3)(A).

28 9. Until restitution has been paid, Defendant shall notify the Clerk of the Court and the  
United States Attorney's Office of any change in Defendant's economic circumstances that


1 might affect Defendant's ability to pay restitution no later than thirty days after the change  
2 occurs. *See* 18 U.S.C. § 3664(k).

3 10. Until restitution has been paid, Defendant shall notify the Clerk of the Court and the  
4 United States Attorney's Office of any change in mailing or residence address, no later than  
5 thirty days after the change occurs. *See* 18 U.S.C. § 3612(b)(1)(F).

6 11. Finally, Defendant Michael Pratt has no right to use, publish, or otherwise exploit  
7 GirlsDoPorn (GDP) or GirlsDoToys (GDT) images, likenesses, or videos. All purported  
8 model releases and other agreements between GDP and/or GDT and its models purporting  
9 to give GDP and/or GDT the right to use, publish, or otherwise exploit its models' images,  
10 likenesses, or videos are void and unenforceable. All transfers, licenses, or leases of the  
11 right to use, publish, or otherwise exploit the models' images, likenesses, or videos by GDP  
12 and/or GDT to any third parties are void. Each model listed in Attachment A holds superior  
13 right, title, and interest in the images, likenesses, and videos depicting that model produced  
14 by GDP and/or GDT. And each model listed in Attachment A (filed under seal) shall have  
15 and recover all property that GDP and/or GDT took from them, including images,  
16 likenesses, videos, and copyrights.
